

PERSONAL DATA PROCESSING NOTICE

(in accordance with Federal Law No. 152-FZ "On Personal Data", Russia)

POSITRON INDUSTRY – Russia Office (hereinafter "the Company"), as a Data Operator, complies with the requirements of the legislation of the Russian Federation regarding the protection of personal data.

Accessing and using our website involves the processing of certain personal data, obtained directly from you or automatically generated through the use of our online platform. The data are processed lawfully, securely, and confidentially, solely for the purposes described below.

1. What is personal data?

Personal data means any information relating to an identified or identifiable natural person (e.g., name, surname, address, phone number, email address, personal identification number, location data, online identifiers, etc.).

2. Legal basis for processing

The processing of personal data is carried out on the basis of: consent of the data subject; performance of a contract; fulfillment of obligations established by the legislation of the Russian Federation; and the legitimate interests of the Company, provided that this does not infringe your rights and freedoms.

6. How data are collected

Personal data may be collected directly from you (via forms, registration, correspondence) or indirectly through cookies and similar technologies.

7. Data transfer and storage

Data may be transferred to authorized public authorities or to company partners only as permitted by law. The Company applies appropriate technical and organizational measures to protect personal data against unauthorized access, loss, or disclosure.

8. Your rights

You have the right to obtain information on the processing of your personal data, to request rectification, blocking or deletion of data, to withdraw consent to processing, and to appeal actions or inactions of the Company to Roskomnadzor or in court.

9. Data retention period

Your personal data will be stored for the duration necessary to achieve the purposes of processing or for the period established by the legislation of the Russian Federation.
